ORDER:-

The Commissioner of Municipal Administration in his letter read above has stated that there are 7 Regional Directorates under the control of the Commissionerate viz., Chengalpattu, Tiruppur, Salem, Vellore, Thanjavur, Madurai and Tirunelveli. During the year 2009-10, under the Part-II Scheme, the Government in its order 2<sup>nd</sup> read above have sanctioned a sum of Rs.60.00 lakhs each for the construction of New Regional Director of Municipal Administration Office Buildings at Madurai and Tirunelveli. Subsequently, during the year 2010-11, under the Part II Scheme Rs.150.00 lakhs was sanctioned for Tiruppur Regional Office and Rs.125.00 lakhs was sanctioned for Salem Regional Office for the construction of New Office Buildings. The work at Madurai is completed and the work at Tirunelveli is not completed. As only a part of the construction cost was sanctioned for the construction of Office Building for Madurai and Tirunelveli Regional Office under Part II Scheme 2009-2010, it is necessary to provide additional grant of Rs.60 lakhs for Madurai Regional office and Rs.75 lakhs for Tirunelveli Regional Office for the provision of construction of meeting hall, additional rooms for the Scheme staff in the first floor with necessary furniture and construction of compound wall under Part II Scheme 2011-12. It has been reported by the Commissioner of Municipal Administration that without the additional funding it's difficult to make use of the Office fully. Hence, the Commissioner of Municipal Administration has requested to sanction Rs.135/- lakhs for completing the building in the above Regions.

2) The Government after careful examination accept the proposal of Commissioner of Municipal Administration and sanction a sum of Rs.60,00,000/- (Rupees sixty lakhs only) and Rs.75,00,000/- (Rupees seventy five lakhs only) towards construction of additional office buildings for Regional Director of Municipal Administration at Madurai and at Tirunelveli respectively under Part II Scheme 2011-12.

3) The amount sanctioned in para 2 above shall be debited to the following Head of Account:-

60 – other Urban Development Schemes  
051 – Construction  
SCHEMES IN THE ELEVENTH FIVE YEAR PLAN  
II – State Plan  
JG – Construction of Office Buildings –

4) The Commissioner of Municipal Administration is authorized to draw the amount sanctioned in para 2 above and to take necessary immediate action in this regard.
