ORDER:-

The Commissioner of Municipal Administration in his letter read above has stated that at present, the Office of the Regional Director of Municipal Administration, Thanjavur is located in the first floor of Gandhi Vaniga Valagam Municipal shopping complex, Thanjavur Municipality on a rental basis. It is proposed to construct a new Office Building for Thanjavur Region at Keeraikolai Village, Block No.1, S.No.31/1 No.7 in Thanjavur Municipal Limit at an approximate cost of Rs.165.00 lakh. It has also been reported by the Commissioner of Municipal Administration the Government have also issued orders transferring land from Municipality vide G.O.Ms.No.245, Municipal Administration and Water Supply Department, dated 15.10.2010 for construction of the Office at the above location. Now, in order to provide own building to Regional Office at Thanjavur for the current year 2011-12 Rs.60.00 lakh and for the next year i.e. 2012-13 Rs.105.00 lakh has been sought for as full grant under Part II Scheme.

2) The Government after careful examination accept the proposal of Commissioner of Municipal Administration and sanction a sum of Rs.60,00,000/- (Rupees sixty lakhs only) for the year 2011-12 towards construction of a new Office Building to the Office of the Regional Director of Municipal Administration, Thanjavur under Part II 2011-12.

3) The amount sanctioned in para 2 above shall be debited to the following Head of Account:-
