**Order:**

The Commissioner of Municipal administration in his letter first read above, has proposed for construction of Disabled Friendly Toilets (68 units) in the Public Buildings in the nine Urban Local Bodies under Part -II Scheme at a cost of Rs.1.37 crore.

2. The Standing Finance Committee has approved the release of a sum of Rs.1.37 crore under Part II Scheme for the year 2011-2012 for construction of Disabled Friendly Toilets in the Public Buildings in the Urban Local Bodies.

3. In his letter third read above, the Commissioner of Municipal Administration, has requested to allot a sum of Rs.1.37 crore as grant (Rupees One Crore Thirty Seven Lakhs only) under Part -II Schemes for 2011-2012 for the construction of Disabled Friendly Toilets in the Public buildings in the nine City Municipal Corporations viz., Madurai, Salem, Coimbatore, Tiruchirapalli, Tirunelveli, Tiruppur, Erode, Vellore and Thoothukudi.

4. The Government, after careful examination, accept the proposal and sanction a sum of Rs.1,37,00,000/- (Rupees One Crore and Thirty Seven lakhs only) as grant for the construction of Disabled Friendly Toilets in the Public buildings for the nine Municipal Corporations viz., Madurai, Salem, Coimbatore, Tiruchirapalli, Tirunelveli, Tiruppur, Erode, Vellore, Thoothukudi under Part II Scheme for the year 2011-2012.

5. The amount sanctioned in para 4 above shall be debited to the following Head of Account -

" 4217 - Capital Outlay on Urban Development - 60 Other Urban Development Schemes - 051 - Construction - Schemes in the Eleventh Five Year Plan - II State Plan - JN - Construction of Disabled Friendly Toilets - 16 - Major works ( DPC 4217-60-051-JN - 1604)"

6. The Commissioner of Municipal Administration is authorised to draw the amount sanctioned in para 4 above and take necessary immediate action in this regard.
