The Following Notification will be published in the next issue of the Tamil Nadu Government Gazette.

## NOTIFICATION

WHEREAS, in G.O. (Ms) No.223, Municipal Administration and Water Supply Department, dated 24.11.1998, a list of parks and play - fields in the area within the jurisdiction of Kadayanallur Municipality was approved under sub - section (2) of section 4 of the Tamil Nadu Parks, Play - fields and Open Spaces (Preservation and Regulation) Act. 1959 and the same was published in the Tamil Nadu Government Gazette

AND WHEREAS, the Commissioner of Town and Country Planning has requested the Government to modify the ward number and survey number of the parks contained in the list approved in the said Government order. The Commissioner of Town and Country Planning has also informed that there is no change in the extent of the notified parks and they remain the same;

AND WHEREAS, the Government after careful examination of the proposal of the Commissioner of Town and Country Planning to modify the Ward number and Survey number of the parks as notified in the said Government Order have decided to accept the same;

NOW, THEREFORE, the following draft of variation to the approved list of parks and play – fields published in the Municipal Administration and Water Supply Department Notification No. II (2)/MW/54/99, at page 22 of Part II-section 2 of the Tamil Nadu Government Gazette, dated the 27th January 1999, which it is proposed to make in exercise of the powers conferred by sub-section (1) of section 5 of the Tamil Nadu Parks, play-fields and open spaces (Preservation and Regulation) Act 1959 (Tamil Nadu Act 26 of 1959) is hereby published as required under sub – section (2) of section 5 of the said Act. Notice is hereby given that objection or suggestion, if any, received in writing, in respect of the said draft variation to the said list from any person interested within seven days from the date of publication of this notification in the Tamil Nadu Government Gazette, will be taken into consideration by the Government of Tamil Nadu.
