The Under Ground Sewerage Schemes have been already implemented in all the Corporation areas and also being implemented in 47 Urban Local Bodies. In the cities and towns where Under Ground Sewerage Schemes are already provided, there are some pockets which are still left out. Therefore, representations have been received from the public for extending the facility to the left out areas of the Corporations and also for extension of the Scheme to all the Urban Local Bodies.

2. Consequently, an announcement has been made by the Hon'ble Minister for Municipal Administration and Rural Development during the Demand No. 34 of the Municipal Administration and Water Supply Department in the Budget Session 2011-2012 as follows :-

"Under Ground Sewerage Scheme will be provided in all the Urban Local Bodies. In the cities where Under Ground Sewerage Scheme has been provided, the left out areas will be covered first. The Detailed Project Report for the uncovered areas of Tiruchirappalli City Municipal Corporation including Sri Rangam, is ready. This scheme will be taken up for implementation immediately at a cost of Rs.328 crores."

3. Pursuant to the above, instructions were issued by the Government in the reference third cited for preparation of Detailed Project Report within 3 months time and the Managing Director, Tamil Nadu Water Supply and Drainage Board, Managing Director, Chennai Metropolitan Water Supply and Sewerage Board, Commissioner of Municipal Administration and Director of Town Panchayats have started preparing the Detailed Project Reports.

4. Accordingly, the Government accords 'in principle' clearance for the implementation of the Under Ground Sewerage Scheme in all the Urban Local Bodies for the towns already provided with Under Ground Sewerage Scheme including the uncovered areas and extended areas within 3 years by following the guidelines indicated in the Annexure to this order.

5. The Managing Director, Tamil Nadu Water Supply and Drainage Board has sent the Detailed Project Reports for Phase I for Under Ground Sewerage Scheme in Srirangam at a cost of Rs.24.00 Crore and phase II for Under Ground Sewerage Scheme in Trichy-West for Rs.195 crore to the Commissioner of Municipal Administration for fund tie up in the reference second and sixth cited. The Commissioner of Municipal Administration in turn has sent the proposals to Tamil Nadu Urban Infrastructure Financial Services Limited for financial appraisal and fund tie up in the reference fourth and seventh cited. The Managing Director, Tamil Nadu Water Supply and Drainage Board has also informed that the Detailed Project Report for Phase III for Under Ground Sewerage Scheme in the other omitted areas and added areas of Tiruchirappalli Corporation is under finalisation.

6. The Government direct that the Detailed Project Reports for all the other towns have to be prepared by the Managing Director, Tamil Nadu Water Supply and Drainage Board and Managing Director, Chennai Metropolitan Water Supply and Sewerage Board within the time line of 3 months as already instructed by the Government.

7. The Government also direct that the Commissioner of Municipal Administration, Director of Town Panchayats, Managing Director, Chennai Metropolitan Water Supply and Sewerage Board and Managing Director, Tamil Nadu Water Supply and Drainage Board to ensure that their proposals along with Detailed Project Report and resolution of the Local Body and funding options are sent to Government for the year 2011-2012 before 30.11.2011, so as to enable the Government to issue Administrative Sanction for the Schemes.

## Annexure

(G.O. (2D) No. 96, Municipal Administration and Water Supply (MC.2) Department dated 15.10.2011)

### Guidelines

a) **Priority** should be given for execution of Under Ground Sewerage Scheme in Urban Towns as per the following order:-

- Left out areas of cities/ towns where already UGSSs has been taken up and completed.
- Expanded areas of the Corporations and Municipalities
- Towns causing pollution to the Rivers.
- Special Grade and Selection Grade Municipalities.
- Towns falling under special categories like Heritage towns, Tourist towns and Hill area town
- Other Smaller Towns

b) Detailed Project Reports may be caused to be prepared by the TWAD Board in consultation with Commissioner of Municipal Administration/Director of Town Panchayats before 31.10.2011. The funds already available with them may be utilized for preparation of Detailed Project Reports.

c) As the Under Ground Sewerage Schemes are to be taken up under fast phase and completed within a period of 3 years the following options may also be examined while preparing Detailed Project Reports:-

- Reducing the land foot print for the sewerage Treatment Plant, Pumping Stations by incorporating latest technologies.
- Adopting latest development in the construction of manholes after necessary field checks, like prefabricated polyethylene manholes etc.
- Adopting suitable new sewer materials.
- Deploying trenchless technology in crossings like Highways and Railways
- Latest Pipe and pumping machineries.
- Innovative remote operating systems.
- Possibilities for establishment of Regional STPs.
- Energy saving methods.
- Best methods of safety in operation and maintenance of the UGSS

d) The Commissioner of Municipal Administration/Director of Town Panchayat should ensure that the DPRs should be prioritized for 2011-2012, 2012 -2013 and 2013-2014 and the proposals should be prepared only after identifying the land for pumping station and Sewerage Treatment Plant. The Detailed Project Reports for the year 2011-2012 should be got appraised by the financial institutions before 15.11.2011.

e) After appraisal by the Financial Institution, the Commissioner of Municipal Administration/Director of Town Panchayats should send the necessary proposals in complete shape with appropriate funding pattern and resolution of the respective Local Bodies to Government before 30.11.2011 for issue of Administrative Sanction.
