ORDER

A comprehensive Solid Waste Management plan covering Chennai City and its suburban areas is an urgent need in the interest of better hygiene and health of the Cities.

Hence, in the Budget Speech for 2011-12, the following announcement has been made relating to Chennai Corporation:-

"This Government will prepare a comprehensive project for Solid Waste Management in Chennai and its suburban areas and avail of Carbon Credits.

3. Earlier in the review meeting held by the Hon'ble Chief Minister on 12.07.2011, a concern was expressed that both the Solid Waste Management Plants at Perungudi and Kodungaiyur proposed in Chennai have not yet taken off for want of environment clearances and also due to other operational problems. Further, the additional generation of Solid Waste expected due to expansion of the urban areas around Chennai Corporation and also in other areas outside Chennai City by the year 2030 was also discussed and the

strategy for the management of the Solid Waste generation in the State as also about the inadequate availability of land for refills in cities and towns. It was finally decided to examine the possibility of establishment of regional land-fills to capture the entire surplus garbage and also the possibilities of going in for power generation wherever there is surplus Solid Waste in the State.

- 4. The Government, therefore, direct the Commissioner, Corporation of Chennai, the Commissioner of Municipal Administration and the Director of Town Panchayat to jointly identify the surplus quantities of garbage in the Cities and towns under their jurisdiction and work out strategies for identification of facility location for establishment of regional land-fills to capture surplus garbage and to formulate proposal for power generation.
- 5. The Commissioner, Corporation of Chennai, the Commissioner of Municipal Administration and the Director of Town Panchayat are requested to jointly consult and send proposals for implementation of the above programme to Government before 30.11.2011.
