^{3.} The Commissioner of Municipal Administration has stated that, the personnel engaged are from June 2009, onwards and can be engaged up to 3 years (based on the performance). An amount of Rs. 1,78,00,000/- was fully released for 1st year (1st instalment) salary for one PMU in the SLNA and ten PIU's implementing Offices by the GOI of which a sum of Rs.2,46,19,947/- has been spent towards specialist's Salary, Travel, Contingency and Operational expenses for which the Utilization Certificate has been sent to Government of India for sanction and release of funds and same has also been forwarded to the GoTN their Lr.Roc.No. 29834/2010/IHSDP-1, DATED 9.6.2011. But the funds are still awaited. As there is necessity of funds for disbursement of Salary, Travel, Contingency and Operational expenses, 2nd installment funds of 1st year

- ((i.e) 100%Government of India share) funds are being used from the interest funds available in the SBI bank IHSDP a/c and the same is being done as an interim arrangement.
- 4. The Commissioner of Municipal Administration has therefore requested the Government to issue orders on the following :
- a. For release the funds of Rs.178.00 lakh to as 2nd installment of 1st year fund in anticipation of Government of India release towards 2nd installment of funds towards 1st year of Salary, Travel, Contingency and Operational PMU /PIU under the BSUP/IHSDP. The same may be adjusted on receipt of the 2nd installment (I year) funds from the Government of India.
- b. Ratify the action taken by the SLNA for releasing interest funds available in the SBI IHSDP a/c for the Project Implementing Offices towards PIU/PMU Salary as an interim arrangement. On receipt of funds from the Government, the same will be adjusted.
- 5. The Government after careful examination accept the proposal of the Commissioner of Municipal Administration at para 4 above and release the amount of Rs.178.00 lakh (Rupees one crore seventy eight lakh only) as 2nd installment of 1st year fund in anticipation of Government of India release towards 1st year of Salary, Travel, Contingency and Operational expenses of the PMU /PIU under BSUP/IHSDP scheme as shown below and to be adjusted on receipt of the 2nd installment (1year) funds from the Government of India.
