In the Government Order 1st read above, the Government have issued orders that the cost of the Traffic Improvement Projects shall be shared between Town and Country Planning Development Fund and the respective Municipalities in the ratio of 75 :25 respectively and that the 75% share of Town and Country Planning Development Fund shall be subject to a maximum of Rs.50.00 lakhs per Municipal Corporation and Rs.25.00 lakhs in the case of Municipalities.
