



## ABSTRACT

#### ORDER:

In the G.O. second read above, the Government has released an amount of Rs.11209.58 lakh as GOI share for the 23 projects under Jawaharlal Nehru National Urban Renewal Mission (JNNURM) – Basic Services to Urban Poor (BSUP) scheme.

2. In the letter first read above, the Commissioner of Municipal Administration has requested the Government, to sanction and release an amount of Rs.528.46 lakh towards the State share of 4<sup>th</sup> instalment to ten ULBs including the 7 ULBs as indicated in the Annexure to this order under JNNURM - BSUP scheme.

3. The Government after careful examination, have decided to agree to the above proposal of the Commissioner of Municipal Administration with some modification and accord for sanction and release an amount of Rs.339.25 lakh (Rupees Three crore thirty nine lakh and twenty five thousand only) as 4<sup>th</sup> instalment State share for 7 ULBs under JNNURM – BSUP scheme sought for by the Commissioner of Municipal Administration as shown in the annexure to this order and defer release of funds to the ULBs of ( Kurichi, Kuniamuthur, Goundampalayam) to whom 3<sup>rd</sup> instalment are yet to be released.

4. The amount sanctioned in para 3 above shall be debited under the following head of account.
