ORDER:

In the letter third read above, the Commissioner of Municipal Administration has stated that the Ministry of Housing and Urban Poverty Alleviation, GOI in the 47th CSC meeting has approved the IHSDP project for the construction of Houses and Infrastructure facilities to the slum dwellers (Urban poor) of Thedavoor Town Panchayats at a cost of Rs.229.55 lakh under IHSDP as detailed below:

2. The Commissioner of Municipal Administration has also stated that in the reference 1st and 2nd read above, the Government have already sanctioned and released 100% of 1st instalment and 2nd instalment of GOI&GOTN share. While releasing the 2nd installment of State share for Thedavoor Town Panchayat a sum of Rs.13.80 lakh has been released instead of Rs.34.46 lakh with a short fall of Rs.20.66 lakh.
