ORDER:

In the letter 3rd read above, the Commissioner of Municipal Administration has stated that the Government have provided funds towards the General Basic Grants under 13th Central Finance Commission recommendation in the Budget Estimate for the year 2011-12 as indicated below:-

General Basic Grant:

1	For the Municipal Corporations (D.P.Code 3604-00-191-JC 0919)	Rs.79,40,03,000 (Rupees Seventy nine crore forty lakh and three thousand only)
2	For the Municipalities (D.P.Code 3604-00-192-JD-0915)	Rs.87,08,42,000 (Rupees Eighty seven crore eight lakh and forty two thousand only)
3	For the erstwhile Grade – III Municipalities (D.P.Code 3604-00-192-JE-0913)	Rs.17,77,10,00 (Rupees Seventeen crore seventy seven lakh ten thousand only)
	Total	Rs.184,25,55,000 (Rupees One hundred and eighty four crore twenty five lakh and fifty five thousand only)

In the G.O.'s 1st and 2nd read above, the Government have released an amount of Rs.184,25,55,000/- as General Basic Grant for the year 2011-12.

2. The Commissioner of Municipal Administration has stated that the GOI in its order dated 12.08.2011 have released an amount of Rs.136,62,00,000/- as 1st installment of General Basic Grant for Municipalities, Municipal Corporations and Town Panchayats for the year 2011-12. As per the GOI sanction, the Commissioner of Municipal Administration is eligible for amount of Rs.195,11,10,692/- as General Basic Grant for the year 2011-2012.

3. The Commissioner of Municipal Administration has therefore requested the Government to release balance amount of Rs.10,85,55,692/- (Rs.195,11,10,692 – Rs.184,25,55,000/-) as General Basic Grant for the year 2011-12 as follows:-

The Government after careful examination accept the proposal of the Commissioner of Municipal Administration at para 3 above and accord sanction and release an amount of Rs.10,85,55,692/- (Rupees ten crores eighty five lakhs fifty five thousand six hundred and ninety two only) as balance General Basic Grant for the year 2011-12.

5. The above expenditure shall be debited under the following head of account.
