**ORDER:-**

WHEREAS Thiru K. Subas Bose, Municipal Engineer, Grade-I of Thanjavur Municipality was placed under suspension from service in the Government Order read above.

AND WHEREAS the said Thiru K. Subas Bose, Municipal Engineer, Grade-I of Thanjavur Municipality (under suspension) attains the age of superannuation on the afternoon of 31.03.2012 and an inquiry into grave charges for Audit objection at Tirumangalam Municipality for the year 2001-2002 to a tune of Rs.21,97,054/- and Local Fund Audit to be conducted at Thanjavur Municipality for the year 2011- 2012 is contemplated.

AND WHEREAS in the circumstances of the case, it is necessary that the said Thiru K. Subas Bose, Municipal Engineer, Grade-I of Thanjavur Municipality (under suspension) shall not be permitted to retire on his reaching the age of superannuation on 31.03.2012 Afternoon, but shall be retained in service.

NOW THEREFORE, it is hereby ordered, under rule 56(1)(c) of the Fundamental Rules, that the said Thiru K. Subas Bose, Municipal Engineer, Grade-I of Thanjavur Municipality (under suspension) is not permitted to retire from service on his reaching the date of superannuation on the afternoon of 31.03.2012 but retained in service until the inquiry into grave charges pending against him is concluded and final orders passed thereon by the Competent Authority.

2. During such extension of service, the service rights of the said Thiru K. Subas Bose (Under suspension) shall freeze at the level reached on the date of superannuation, i.e. 31.03.2012 afternoon and the salary during the period shall not exceed the amount of pension which would have accrued to him on the date.
