In the reference 5th read above, the Commissioner of Municipal Administration has stated that the Government of India has since conveyed the approval for payment of General Basic grant and approval for sanction of General Performance grant. Accordingly the Commissioner of Municipal Administration has sent a necessary proposal for sanction of Rs.4,02,85,448/-(Rupees Four crore two lakh eighty five thousand four hundred and forty eight only) towards the balance of General Basic Grants and Rs.12,25,00,134/-(Rupees Twelve crore twenty five lakh one hundred and thirty four only) towards the General Performance Grant for the Corporations, Municipalities including erstwhile Grade-III Municipalities under the recommendations of the 13th Central Finance Commission for the year 2011-12 as follows:

- 4. The Commissioner of Municipal Administration has therefore requested the Government to issue orders to release the above grants and authorize him for drawing and disbursing the amount to all Corporations and Municipalities including erstwhile Grade III Municipalities for the year 2011-12.
