In the reference first read above, the Government have issued orders to establish a Housing Startup Index (HSUI) cell in Chennai, Coimbatore, Madurai and Trichirapalli Corporations for which the Government of India has released a sum of Rs.11,40,000/- as the 1st installment for establishment of Housing startup Index (HSUI) Cell for the above Urban Local Bodies

In the reference second read above, the Government of India, Ministry of Urban poverty Alleviation, National Buildings Organization has released a sum of Rs.11.40,000/- (Rupees Eleven lakh forty thousand only) to Chennai, Coimbatore, Madurai and Trichirapalli Corporations as the 2nd installment for establishment of HSUI Cell for development of Housing Startup Index in selected cities/towns, subject to certain conditions. The Government after careful examination accept the proposal of the Commissioner of Municipal Administration at para 3 above and accord sanction and release an amount of Rs.11,40,000/-(Rupees Eleven lakh forty thousand only) as the 2nd installment for establishment of HSUI Cell for development of Housing Startup Index in Chennai, Coimbatore, Madurai and Trichirapalli Corporations.
