#### **ORDER:-**

In the Government order first read above four posts of Assistant Executive Engineer (one post for each of the four wards) and one post of Assistant Executive Engineer (Mechanical & Solid Waste Management) were sanctioned. The Commissioner, Salem City Municipal Corporation in his letter second read above has stated that out of the five posts of Assistant Executive Engineers sanctioned in the above G.O. only three were filled up and two posts are yet to be filled up. He has therefore requested the Commissioner of Municipal Administration to depute two Assistant Executive Engineers belonging to the Tamil Nadu Municipal Engineering Service Rules to supervise various scheme works in Salem Corporation until the Junior Engineers/Assistant Engineers in Tamil Nadu Corporation Engineering and Water Supply Service are promoted.

2. The Commissioner of Municipal Administration has sent a proposal to post Thiru M. Mohan, Assistant Executive Engineer, Tamil Nadu Municipal Engineering Service on deputation in the vacant post of Assistant Executive Engineer in Salem City Municipal Corporation.
