ORDER:

In the letter first read above, the Government of India have issued guidelines towards the utilisation of grants recommended by the Thirteenth Finance Commission for Rural and Urban Local Bodies.

- 2) In the references second to fifth read above, the State Government have released the second instalment of General Basic Grants to the local bodies pending receipt of grants from Government of India.
- 3) As per the guidelines issued by Government of India in the letter first read above, among other things, the Local Body Grant must be transferred within the stipulated number of days i.e. five days of receipt from the Central Government in case of States with easily accessible banking infrastructure and ten days in case of States with inaccessible banking infrastructure. Any delay will require the State Government to release the instalment with interest, at the Bank rate of Reserve Bank of India for the number of days of delay. This would be applicable from the second instalment of 2010-11 onwards.
- 4) In the references sixth and seventh read above, the Government of India have released second instalment of General Basic Grant for the year 2011-12 and General Performance Grant for the year 2011-12. The amount released by the Government of India as second instalment of General Basic Grant for 2011-12 is on the higher side as against the funds released by the State Government as General Basic Grant for 2011-12 pending receipt of grant from Government of India. In the references eighth to eleventh read above, the State Government have released the balance of second instalment of General Basic Grant for 2011-12 and General Performance Grant for 2011-12 to the local bodies.
- 5) Based on the Government of India's guidelines and release of grant made by Government of India, the State Government have released funds to the local bodies and interest to be paid for delayed payment of grant to local bodies, are tabulated below:-

6) Government after careful consideration, have decided to accord sanction and release a sum of Rs.37,11,264/- (Rupees thirty seven lakhs, eleven thousand, two hundred and sixty four only) to the Heads of Departments as detailed below towards payment of interest to the respective local bodies at the rate of 9.5% in lieu of delay in release of balance amount of second instalment of General Basic Grant for the year 2011-12 and General Performance Grant for the year 2011-12:-

i) Commissioner of Municipal Administration: Rs.11,96,812

ii) Director of Town Panchayats : Rs. 4,66,853

iii) Commissioner of Rural Development : and Panchayat Raj :Rs.20,47,599

7) The expenditure sanctioned in paragraph 6 above shall be debited to the following head of account:-

"2049. Interest Payments – 60. Interest on Other Obligations – 800. Others – AA. Interest on Finance Commission transfers to Local Bodies – 25. Interest (DPC 2049 60 800 AA 2509) (Charged)"

- 8) Necessary funds will be provided in RE / FMA 2012-2013. Pending provision of funds in RE / FMA 2012-13, the Pay and Accounts Officer (Secretariat) is requested to admit the bills as and when presented, if otherwise found in order.
- 9) The Section Officer (Bills), Finance department is authorised to draw and disburse the amount sanctioned in paragraph 6 above to the concerned head of departments by account payee cheque.

- 10) The Commissioner of Municipal Administration is requested to disburse the amount to Corporation, Municipalities and Erstwhile Grade-III Municipalities as per the amount mentioned in paragraph 5 above.
