ORDER:

In the letter read above, the Commissioner of Municipal Administration has requested the Government to sanction a sum of Rs.40,00,000/- under Part-II Scheme for the year 2012-2013 for purchasing a new Jet Rodding Machine to the Chinnamanur Municipality.
