### ORDER:-

The Commissioner of Municipal Administration in his letter first read above has proposed for Construction of new modern Slaughter Houses in the 5 Municipalities viz Rasipuram, Dharmapuri, Hosur, Thiruthani, Poonthamallee at an estimated cost of Rs.100.00 lakhs under Part-II Schemes for the year 2012-13.

2) The Government after careful examination accept the proposal and sanction a sum of Rs.100.00 lakhs (Rupees one hundred lakhs only) as grant for the Construction of new modern Slaughter Houses in the 5 Municipalities (Rasipuram, Dharmapuri, Hosur, Thiruthani, Poonthamallee) under Part-II Schemes for the year 2012-13.

3) The amount sanctioned in para 2 above shall be debited to the following Head of Account:-

"2217 – Urban Development – 05 Other Urban Development Schemes – 192 Assistance to Municipalities/Municipal Councils – Schemes in the Twelfth Five Year Plan – II State Plan – JE Construction of Slaughter Houses in Municipalities – 09 Grants – in-aid – 02. Grants for Capital Expenditure.

4) The Commissioner of Municipal Administration is authorised to draw and disburse the amount sanctioned in para 2 above and take necessary immediate action in this regard.


