**ORDER:-**

WHEREAS Thiru R. Rajasekaran, Executive Engineer (Under Ground Sewerage Scheme) Dindigul Municipality was placed under suspension from service in the Government Order read above;


AND WHEREAS the said Thiru R. Rajasekaran, Executive Engineer (Under Ground Sewerage Scheme), Dindigul Municipality (under suspension) attains the age of superannuation on the afternoon of 30.06.2012 and the disciplinary proceedings for having committed irregularities in Arani, Sivakasi, and Theni Allinagaram Municipalities and caused loss of revenue to the tune of Rs.1,33,62,207/- (Rupees one crore thirty three lakhs sixty two thousand two hundred and seven) to the Municipal funds is pending.

AND WHEREAS in the circumstances of the case, it is necessary that the said Thiru R. Rajasekaran, Executive Engineer (Under Ground Sewerage Scheme), Dindigul Municipality (under suspension) shall not be permitted to retire on his reaching the age of superannuation on 30.6.2012 Afternoon, but shall be retained in service.

NOW THEREFORE, it is hereby ordered, under rule 56(1)(c) of the Fundamental Rules, that the said Thiru R. Rajasekaran, Executive Engineer (Under Ground Sewerage Scheme), Dindigul Municipality (under suspension) is not permitted to retire from service on his reaching the date of superannuation on the afternoon of 30.6.2012 but retained in service until the disciplinary proceedings pending against him is concluded and final orders passed thereon by the Competent Authority.

2. During such extension of service, the service rights of the said Thiru R. Rajasekaran (under suspension) shall freeze at the level reached on the date of superannuation, i.e. 30.6.2012 afternoon and the salary during the period shall not exceed the amount of pension which would have accrued to him on the date.
