



ABSTRACT

Pudukottai and Sivagangai Districts – Providing Combined Water Supply Scheme to 1766 rural habitations in Viralimalai (part), Annavasal (part), Ponnamaravathy, Thirumaiyam, Arimalam, Kunnandarkovil (part), Pudukottai (part) Panchayat Unions in Pudukottai District and 125 habitations in S. Pudur and Sakottai Panchayat Unions of Sivagangai district with River Cauvery as source at a cost of Rs.301.50 crore for installation and a sum of Rs.10.86 crore for annual maintenance - Recommended by the Empowered Committee – Administrative Approval – Accorded - Orders - issued.

ORDER:-

The Hon'ble Minister for Municipal Administration and Rural Development while moving Demand No.34 for the year 2012-13 among others, has announced that Combined Water Supply Scheme for 3642 Rural Habitations in 14 Panchayat Unions of Pudukottai and Sivagangai Districts and Vallam Town Panchayat in Thanjavur District with River Cauvery and Kollidam as source would be taken up for implementation during the year 2012 - 13.

2 The Managing Director, Tamil Nadu Water Supply and Drainage Board in his letter read above, has stated that as announced by the Hon'ble Minister for Municipal Administration and Rural Development, the Combined Water Supply Scheme for 3642 Rural Habitations in 14 Panchayat Unions of Pudukottai and Sivagangai Districts and Vallam Town Panchayat in Thanjavur District with River Cauvery and Kollidam as source are formulated in two parts as detailed below:-

- (1) Combined Water Supply Scheme to 1766 rural habitations in Viralimalai (part), Annavasal (part), Ponnamaravathy, Thirumaiyam, Arimalam, Kunnandarkovil (part), Pudukottai (part) Panchayat Unions in Pudukottai District and 125 habitations in S.Pudur & Sakottai Panchayat Unions of Sivagangai district with River Cauvery as source near Thirupparaithurai.

- (2) Combined Water Supply Scheme to 1751 rural habitations in Viralimalai (part), Annavasal (part), Aranthangi, Kunnandarkovil (part), Pudukottai (part) Gandharvakottai, Karambakudi and Thiruvankulam Panchayat Unions in Pudukottai District with River Kollidam as source near Thiruchennampoondi Padugai.

3. The Managing Director, Tamil Nadu Water Supply and Drainage Board has also stated that the DPR was prepared for providing Combined Water Supply Scheme to 1766 rural habitations in Viralimalai (part), Annavasal (part), Ponnamaravathy, Thirumaiyam, Arimalam, Kunnandarkovil (part), Pudukottai (part) Panchayat Unions in Pudukottai District and 125 habitations in S.Pudur & Sakottai Panchayat Unions of Sivagangai district with River Cauvery as source near Thirupparaithurai at a cost of Rs.301.50 crore to install and Rs.10.86 Crore to maintain annually. The cost per 1000 litres work out to Rs.27.01 and the per capita cost is Rs.5439/-. The cost of the above scheme is given as detailed below :-

The Managing Director, Tamil Nadu Water Supply and Drainage Board has also stated that the above proposal has been placed before the Board and the Empowered Committee for its approval.

4. The Board in its meeting held on 12.7.2012 vide its resolution No.2.8 has resolved to recommend to the Empowered Committee for recommending to Government for according Administrative Sanction for the proposal.

5. Based on the recommendation of the Board, the Empowered Committee, after careful consideration, has resolved to recommend to Government for according Administrative Sanction for the proposal for providing Combined Water Supply Scheme to 1766 rural habitations in Viralimalai (part), Annavasal (part), Ponnamaravathy, Thirumaiyam, Arimalam, Kunnandarkovil (part), Pudukottai (part) Panchayat Unions in Pudukottai District and 125 habitations in S. Pudur and Sakottai Panchayat Unions of Sivagangai district with River Cauvery as source at a cost of Rs.301.50 crore to install and Rs.10.86 crore to maintain annually and to implement the scheme with grant under Minimum Needs Programme / National Rural Drinking Water Programme.

6. As resolved by the Empowered Committee, the Managing Director, TWAD Board has sent a proposal to Government for according administrative approval for the above scheme.

7. Based on the recommendations of the Empowered Committee, the Government, after careful examination, accept the proposal of the Managing Director, TWAD Board and accord administrative approval for the implementation of Combined Water Supply Scheme to 1766 rural habitations in Viralimalai (part), Annavasal (part), Ponnamaravathy, Thirumaiyam, Arimalam, Kunnandarkovil (part), Pudukottai (part) Panchayat Unions in Pudukottai District and 125 habitations in S. Pudur and Sakottai Panchayat Unions of Sivagangai district with River Cauvery as source at a cost of Rs.301.50 crore (Rupees Three hundred and one crore and fifty lakhs only) to install and Rs.10.86 crore (Rupees ten crore and eighty six lakhs only) to maintain annually and to implement the scheme with grant under Minimum Needs Programme / National Rural Drinking Water Programme.
