### ORDER:

The Town Panchayats should provide toilet facilities which is a mandatory one as per section 147 of Tamil Nadu District Municipalities Act, 1920. The toilet facilities now available are not matching the needs of town Panchayats and there is an absolute need to have sanitary complex with a view to eradicate open defecation. The Director of Town Panchayat has therefore proposed to provide sanitary complexes in 3 Town Panchayats at a cost of Rs.40.00 lakhs under Part –II Scheme for the year 2012-2013.

2. The Government after careful examination, accept the proposal of Director of Town Panchayat and sanction a total sum of Rs.40,00,000/- (Rupees Fourty lakh only) for construction of 4 Sanitary Complex in 3 Town Panchayats under Part – II Scheme for the year 2012-2013, as per the annexure to this Government Order.

3. The amount sanctioned in para 2 above shall be debited to the following head of account:-

“2515 – 00 – Other Rural Development Programmes - 800 – Other Expenditure- Schemes in the Twelfth Five Year Plan - II State Plan - KJ – Assistance to Town Panchayat for infrastructure Development - 09 – Grants – in – Aid - 03 – Grants for specific schemes”

4. The Director of Town Panchayats is authorized to draw and disburse the amount sanctioned in para 2 above, based on the need at the appropriate stage to the concerned Town Panchayats. He is also requested to send the completion report to the Government.
