ORDER:

During the budget discussion on demand for grants (Demand No.35) of Personnel and Administrative Reforms (Training) Department for the year 2011-2012 held in the Legislative Assembly on 14.09.2011, the Hon'ble Minister (Information, Law, Courts and Prisons) had announced that the Best Practices Award will be presented by the Hon'ble Chief Minister on every year on Independence day for those who achieve excellent results in Good Governance and who have successfully implemented strategies, new initiative and Best Practices which will guide others in extending good services to the public and making the schemes and services of Government to reach the public in a systematic way.

2. The Director, Anna Institute of Management and Director General of Training has sent necessary proposal to Government in this regard and requested the Government to sanction an annual grant of Rs.20,00,000/-lakhs for the Best Practices Award activities.

3. The Government, after careful examination of the proposal of the Director, Anna Institute of Management and Director General of Training accord sanction an annual grant for a sum of Rs.14,00,000/- (Rupees Fourteen lakhs only) for giving the best practices award to be distributed by the Hon'ble Chief Minister on Independence Day every year for improvement of quality delivery system ensuring Good Governance and sustaining Development as detailed below.

- i) The department shall give "Innovations and good governance initiatives" award for three persons every year @ Rs.2.00 lakhs (Rupees Two lakhs only) each. This may be on public service improvement or Developmental initiatives or tax and administrative reforms etc., totally this will cost Rs.6.00 lakhs per annum.

- ii) Besides this, Rs. 6.00 lakhs may be given for administrative expenses to Anna Institute of Management and 2.00 lakhs for documentation.

4) The expenditure sanctioned in para 3 above shall be debited to the following new head of account opened under Demand No:35-06 :-

5. The Director, Anna Institute of Management and Director General of Training is the Estimating, Reconciling and Controlling authority for the above new head of account.

6. The Pay and Accounts Officer concerned is requested to open the above new head of account in their accounts.

The expenditure sanctioned at para 3 above, shall constitute an item of "New Service" and the approval of the Legislature shall be obtained in due course by specific inclusion in the Supplementary Estimates for the year 2011-2012. Pending approval of the Legislature, the expenditure shall initially be met by drawal of an advance from the Contingency Fund. Orders regarding this will be issued by the Finance (BG.I) Department separately. The Director, Anna Institute of Management and Director General of Training shall apply to the Government in Finance (BG.I) Department in the prescribed format along with a copy of this order for sanction of an advance from the Contingency Fund. The Director, Anna Institute of Management and Director General of Training shall also send necessary draft explanatory notes for inclusion of the expenditure in the Supplementary Estimates for the year 2011-2012 without fail.
