ORDER:

In the letter read above, the Director of Town Panchayat has requested the Government to sanction a sum of Rs.841.00 lakhs under Part-II Schemes for the year 2011-2012 for construction of 20 new office buildings for the Town Panchayats and Assistant Director of Town Panchayats at an estimated cost of Rs.549.00 lakhs and for improvement of existing Water Supply Scheme in 13 Town Panchayats at an estimated cost of Rs.292.00 lakhs.

2. The Government after careful examination, accept the proposal of Director of Town Panchayat and sanction a total sum of Rs.8,41,00,000/- (Rupees Eight crore and forty one lakhs only) for construction of 20 new office buildings for the Town Panchayats and Assistant Director of Town Panchayats at an estimated cost of Rs.5,49,00,000 /- and improvement of existing Water Supply Scheme in 13 Town Panchayats at an estimated cost of Rs.2,92,00,000 /- under Part – II Schemes for the year 2011-2012, as per the annexure I and II to this Government Order.

3. The amount sanctioned in para 2 above shall be debited to the following head of account:-
