ORDER:

In the Government Order first read above, orders were issued to the effect that the outstanding loans of Tamil Nadu Slum Clearance Board to the HUDCO / TUFIDCO to the extent of Rs.99,36,12,000/- will be taken over by the Government and that the Principal and Interest will be serviced by the Government with effect from 1.4.2005 with certain conditions.

2) In the letter second read above, the Managing Director, Tamil Nadu Slum Clearance Board has stated that the HUDCO Chennai has raised a demand for Rs.1,91,56,972/- and as per TNSCB record the amount is Rs.1,98,68,151/- and has therefore requested sanction for TNSCB calculation towards repayment of Principal of Rs.1,53,71,000/- and interest of Rs.44,97,151/- to HUDCO for the quarter ending, 31.08.2011.

3) The Government after careful examination accept the request of the Managing Director, Tamil Nadu Slum Clearance Board and accordingly, sanction a sum of Rs.1,98,68,151/- (Rupees One crore ninety eight lakhs sixty eight thousand and one hundred and fifty one only) towards payment of interest and repayment of principal to HUDCO for the quarter ending 31.08.2011.
