ORDER:

In the letter read above, the Managing Director, Tamil Nadu Housing Board has requested the Government to allocate a total amount of Rs.1,40,00,000/- (Rupees One Crore and forty lakhs only) for construction of 12 Numbers of flats in Master Plan Complex, Villupuram under Tamil Nadu Government Servants Rental Housing Scheme at an estimate cost of Rs.1,40,00,000/-.

2. The Government after careful consideration accept the proposal of the Tamil Nadu Housing Board and accord sanction a sum of Rs.1,40,00,000/- (Rupees One crore and forty lakhs only) to the Tamil Nadu Housing Board towards the construction of 12 Nos of flats in Master Plan Complex, Villupuram under Tamil Nadu Government Servants Rental Housing Scheme under Part-II Scheme 2011-12.

3. The amount sanctioned in Para 2 above shall be debited to the following Head of Account:-

“4216 Capital outlay on Housing 01 – Government Residential Buildings
700 – Other Housing – Schemes in the Eleventh Five year Plan – II State Plan –
JH Construction of Houses under Tamil Nadu Government Servants Rental
Housing Scheme – Executed by Tamil Nadu Housing Board – 16 Major works”.

4. The amount sanctioned in Paragraph 2 above shall not be paid in cash but credited to the following Head of Account.

“K” Deposits and Advances (b) – Deposits not bearing interest – 8443 – Civil Deposits – 800 – other Deposits BI – Deposits of Tamil Nadu Housing Board (TNHB) (D.P Code No.8443-00-800-BI-000E (Receipts)”.

5. The Commissioner of Treasuries and Accounts is authorized to draw the amount sanctioned in Paragraph 2 above by means of an Account Payee Cheque in favour of Personal Deposit Account of Tamil Nadu Housing Board by indicating the Account Number thereon and disburse the same to the Tamil Nadu Housing Board so as to enable the Tamil Nadu Housing Board to remit the same in the bank in which the said Personal Deposit Account is maintained.

6. The Managing Director, Tamil Nadu Housing Board is requested to furnish the Utilisation Certificate for the amount sanctioned in Paragraph 2 above.
