ORDER:

In the G.O first read above, orders have been issued to enhance the Financial Assistance of Town and Country Planning Development Fund to maintain the Park and Play fields and also ordered that, a minimum contribution of 10% (i.e. Rs.25,000) may be collected from urban local bodies and the grant from Town and Country Planning fund would be 90% (i.e. Rs.2.25 lakhs) for maintenance of Park and Play fields.

2. The Director of Town and Country Planning in his letter second read above has stated that, while moving the Demand for Housing and Urban Development Department, the Hon'ble Minister (Housing and Urban Development Department), among others has announced that, as per the instructions of the Hon'ble Chief Minister, the grant amount of Rs.2.25 lakhs will be increased to Rs.10.00 lakhs for each Park under the Park improvement programme. Hence, the Director of Town and Country Planning has requested the Government to issue necessary orders that, the 90% share of Town and Country Planning Development Fund shall be increased to a maximum of Rs.10.00 lakhs from Rs.2.25 lakhs for each Park under the programme for improvement of Park and Play fields.

3. The Government after careful examination accept the proposal of the Director of Town and Country Planning in para 2 above and order that, the grant amount of Rs.2.25 lakhs shall be increased to Rs.10.00 lakhs as 90% grant from

Town and Country Planning Development Fund under the programme for improvement of Park and Play fields. The Government also order that the minimum contribution of 10% (i.e. Rs.25,000) collected from the local bodies shall be increased to Rs.1.00 lakh, for maintenance of Park and Play fields.

4. This order issues with the concurrence of the Finance Department vide its U.O.No.13091/Hg/2012, Dated 06.03.2012.
