ORDER :

In the G.O. 2nd read above, orders have been issued directing the Director of Local Fund Audit to audit the accounts of Contributory Pension Scheme in respect of the following employees after the completion of each financial year:-

- (i) Teachers of Panchayat Union Schools
- (ii) Teachers of Aided Schools / Institutions
- (iii) Non-Teaching Staff of Panchayat Union Schools
- (iv) Municipal Corporation and Municipal Employees
- (v) Non - Provincialised Employees of Town Panchayats
- (vi) Non - Provincialised Employees of Panchayat Unions.

The Director of Local Fund Audit shall audit the accounts of Contributory Pension Scheme in respect of the above employees after the completion of each financial year. The Director of Local Fund Audit shall issue a certificate every financial year. The Director of Local Fund Audit shall issue a certificate every financial year to the effect that subscriptions made by the employees and employer's contribution for the respective Department has been remitted in to the Government Account.

2. In the D.O. Letter fourth read above, the Commissioner, Government Data Centre has suggested to issue orders, to entrust the auditing of Contributory Pension Scheme accounts of all the Departments other than the Departments which are

audited by the Local Fund Audit Department and also the Aided Schools / Aided Colleges / Welfare of Differently Aabled persons Department, to the Chief Internal Auditor and Chief Auditor of Statutory Boards, so as to enable the Government Data Centre to issue the account slips to the employees without any error / omission, as ordered in G.O. Ms.No.201, Finance (Pension), dated 29.05.2010.

3. After careful examination, the Government accept the suggestion of the Commissioner Government Data Centre and direct that the Chief Internal Auditor and Chief Auditor of Statutory Boards shall audit the accounts of the Contributory Pension Scheme in respect of Aided Schools / Aided Colleges / Welfare of Differently Aabled persons Department, and all the Departments other than the Departments which are audited by the Local Fund Audit Department, so as to issue the Contributory Pension Scheme Account slips by the Government Data Centre to the employees without any error/ omission, as ordered in G.O.Ms.No.201, Finance (Pension), dated 29.05.2010.
