ORDER:

In the G.O. first read above, the Government had released the 3rd installment of GOI and GOTN share of Rs.406.24 lakh and in the G.O. second read above, the Government had also released 4th installment of GOI share of Rs.212.21 lakh to Kurichi, Kuniamuthur and Goundampalayam Municipalities under JNNURM – BSUP scheme.

2. In the G.O. third read above, the Government released a sum of Rs.339.25 lakh towards 4th installment of State share under JNNURM - BSUP scheme to 7 Municipalities and deferred the release of Rs.189.21 lakh to 3 Municipalities (ie, Kurichi, Kuniamuthur and Goundampalayam) as the 3rd

installment has not been released by the Commissioner of Municipal Administration for these 3 Municipalities.

3. In the letter fourth read above, the Commissioner of Municipal Administration, has requested the Government to release the 4th installment of State share to the Kurichi, Kuniyamuthur and Goundampalayam Municipalities, in order to expedite the work at the earliest.

4. The Government after careful consideration accepts the proposal of Commissioner of Municipal Administration and release an amount of Rs.189.21 lakh (One crore Eighty nine lakhs and Twenty one thousand only) as 4th instalment state share to Kurichi, Kuniyamuthur and Goundampalayam Municipalities as detailed below.
