#### ORDER:

In the Government Order first read above, the Government have sanctioned a sum of Rs.129,20,54,017/- to the Municipal Corporations, Municipalities and Grade-III Municipalities as first instalment of General Basic Grant under the recommendation of Thirteenth Finance Commission for the year 2012-13 as detailed below:

2. In the reference second read above, Government of India has conveyed the approval for payment of Rs.14966.25 lakhs to Urban Local Bodies as first instalment of General Basic Grant for the year 2012-13.

3. In the Government Order third read above, the Government have sanctioned a sum of Rs.86,13,69,345/- to the Municipal Corporations, Municipalities and Grade-III Municipalities as 2<sup>nd</sup> instalment of General Basic Grant under the recommendation of Thirteenth Finance Commission for the year 2012-13 as detailed below:-

4. In the reference fourth read above, Government of India has released a sum of Rs.16481.82 lakhs to Urban Local Bodies as second instalment of General Basic Grant for 2012-13. The releases made by GOI as General Basic Grant for 2012-13 to Urban Local Bodies in two instalments is Rs.15,13,76,638/- higher than the releases already made by the State Government to the Urban Local Bodies in two instalments.

5. After careful consideration, the Government has decided to sanction and release the balance of second instalment of Rs.10,88,97,780/- (Rupees Ten crore Eighth Eight lakh Ninety Seven Thousand Seven hundred and Eighty only) as General Basic Grant for 2012-13 to the Municipal Corporations, Municipalities and Grade-III Municipalities.

6. The expenditure sanctioned in para 5 above, shall be debited to the following heads of accounts:-

Pending provision of such funds, the Commissioner of Municipal Administration is authorized to draw and disburse the amount sanctioned at para 5 above, and he also requested to include this expenditure while sending the proposal for FMA 2012-13 to Government in Finance Department without fail.

8. The Commissioner of Municipal Administration is authorized to draw the amount sanctioned in para 5 above and 6 above to all the Civic Bodies. He is also directed to furnish necessary Utilization Certificate towards the utilization of funds sanctioned in para 4 above in order to forward the same to the Government of India.
