#### ORDER:-

In the letter 2<sup>nd</sup> read above, the Director of Town Panchayats has reported that, the Detailed Project Report for Construction of Night Shelter at an estimated cost of Rs.25.00 lakh in Kalavai Town Panchayat, Vellore District and construction of sanitary complex at an estimated cost of each Rs.15.00 lakh in Konganapuram Town Panchayat of Salem and Ayakudi Town Panchayat in Dindigul District respectively, has been sent to HUDCO for availing grant under Corporate Social Responsibilities assistance for necessary action.

2. In the letter 1<sup>st</sup> read above the Deputy General Manager(P), HUDCO has informed to the Director of Town Panchayats that the above proposals are being processed by HUDCO and the HUDCO Board has approved the amendment in the Corporate Social Responsibilities Policy "to restrict HUDCO's maximum stake to 90% of the project cost(excluding land cost, which is provided free of cost) and 10% to be borne by the State Government. Therefore, it has been requested to furnish the following information/ documents for further processing the above proposal under Corporate Social Responsibilities:-

- (i) Commitment from the State Government for Providing 10% of the project cost.
- (ii) Approval from the State Government for availing grant from HUDCO for implementation of above proposals.

3. Pursuant to the above, the Director of Town Panchayats has informed that with regard to commitment on contribution of State fund of 10% amount of the project cost it will be met from the funds of the Town Panchayats since, it would pave way for easy access of funds. He has therefore requested the Government, to accord sanction for implementing the above projects with the assistance of HUDCO and Town Panchayats funds.

4. The Government, after careful examination have decided to accept the proposal of Director of Town Panchayats. Accordingly the Director of Town Panchayats is permitted to avail the 90% Grant sanctioned by the HUDCO for implementing the projects for construction of night shelter at an estimated cost of Rs.25.00 lakh in Kalavai Town Panchayat, Vellore District and construction of Sanitary complexes at an estimated cost of each Rs.15.00 lakh in Konganapuram Town Panchayat in Salem District, and Ayakudi Town Panchayat in Dindugul District respectively with 10% commitment by the respective Town Panchayats.
