ORDER:

In the reference read above, Government of India has conveyed the approval for payment of Rs.32,04,51,000/- to Urban Local Bodies as General Performance Grants forfeited by non-performing States to performing and non-performing States for the year 2012-13 as per recommendation of the Thirteenth Finance Commission.

2. Accordingly, the Government has decided to sanction and release a sum of Rs.23,05,27,002/- (Rupees Twenty three crores five lakhs twenty seven thousand and two only) as the General Performance Grants to the Municipal Corporations, Municipalities and Grade-III Municipalities for the year 2012-13 under the recommendation of Thirteenth Finance Commission as detailed below:
