



ABSTRACT

Establishment – Tamil Nadu Municipal Engineering Service – Thiru K. Subas Bose, Municipal Engineer Grade-1 – Placed under suspension and not allowed to retire from service on attaining the age of superannuation – Suspension revoked and allowed to retire from service on the afternoon of 31.03.2012 without prejudice to the Audit Objection to be raised against him – Orders – Issued.

ORDER:-

In the Government Order first read above, for the pending audit objections at Tirumangalam Municipality for the year 2001-2002 and pending audit to be conducted at Thanjavur Municipality for the year 2011-2012, Thiru K.Subas Bose, Municipal Engineer Grade-1, Thanjavur Municipality was placed under suspension. In the Government Order second read above, on reaching the date of superannuation on the After Noon of 31.03.2012, he was not allowed to retire and retained in service.

2. The Commissioner of Municipal Administration in his letters sixth read above has stated that the individual was relieved of from the audit paras pending in Tirumangalam Municipality and the Commissioner, Tirumangalam Municipality in his letter fourth read above issued "No Objection Certificate" regarding the retirement of Thiru K.Subas Bose, Municipal Engineer Grade-1, Thanjavur Municipality (under suspension).

3. The Commissioner of Municipal Administration has stated that the Commissioner, Coimbatore Corporation in his letter third read above has certified that there are no disciplinary cases/ advance / audit objections pending against Thiru K.Subas Bose, Municipal Engineer Grade-1, Thanjavur Municipality (under suspension).

4. The Commissioner of Municipal Administration has stated that the Commissioner, Thanjavur Municipality in his letter fifth read above has stated that the individual had worked for the period from 11.12.2011 to 31.03.2012 in that Municipality and the Local Fund Audit has not yet been taken up for the year 2011-2012.

5. The Commissioner of Municipal Administration has further added that, as there is no disciplinary cases/ advance / audit objections are pending against Thiru K.Subas Bose, Municipal Engineering Grade-I (under suspension), and requested the Government to revoke the suspension of Thiru K.Subas Bose, Municipal Engineering Grade-I and to allow him to retire from service on the After Noon of 31.03.2012 without prejudice to the Local Fund audit objections to be raised for the period 2011-2012 in Thanjavur Municipality.

The proposal of the Commissioner of Municipal Administration has been examined in detail by the Government independently and with the records in hand and it is proposed to revoke the suspension of Thiru K.Subas Bose, Municipal Engineering Grade-I and to allow him to retire from service on the After Noon of 31.03.2012 without prejudice to the Local Fund audit objections to be raised for the period 2011-2012 in Thanjavur Municipality when it is taken up for audit.

Now therefore, the Government in exercise of the powers conferred by Sub-rule 8(14) of Tamil Nadu Municipal Service (Discipline and Appeal) Rules, 1970 hereby revokes the said order of suspension and permit Thiru K.Subas Bose, Municipal Engineer Grade-1, Thanjavur Municipality (under suspension) to retire from service with effect from 31.03.2012 afternoon without prejudice to the audit objection to be raised against the individual for the period 2011-2012 in Thanjavur Municipality when it is taken up for audit.
