ORDER :

In the Government Order first read above orders were issued appointing Dr. P. Kanagasabapathi as Director, Tamil Nadu Institute of Urban Studies, Coimbatore on contract basis for a period of three years from the date of assumption of charge in the post.

2. In the Government Order second read above, orders were issued extending the tenure of the appointment of Dr. P. Kanagasabapathi as Director of Tamil Nadu Institute of Urban Studies, Coimbatore for two more years on contract basis from 22.01.2010.

3. The Commissioner of Municipal Administration in his letter third read above has stated that Dr. P. Kanagasabapathi is going to complete five years of service as Director, Tamil Nadu Institute of Urban Studies, Coimbatore on 21.01.2012. Therefore, a new candidate has to be selected for appointment in the post of Director, Tamil Nadu Institute of Urban Studies, Coimbatore by following the procedures prescribed in the Regulations of Tamil Nadu Institute of Urban Studies, Coimbatore for recruitment of the Group A post.

4. The relevant part of the Service Regulation as in Chapter III Part I (2) is as follows :-

The Management Committee will form a Search Committee to select the members through advertisement in newspaper by addressing Universities / National Level Institutions in the Country. The Commissioner of Municipal Administration representing the Management Committee and two outside members representing a National Level Institution will form the Search Committee, who will complete the task within 45 days and place a panel of three names to the Management Committee. The Management Committee will recommend the name to Government for appointment.

5. The Commissioner of Municipal Administration has also stated that a period of three months is required to follow the procedures prescribed in the Regulations of Tamil Nadu Institute of Urban Studies, Coimbatore for completing the process of appointment of a new Director and he has requested the Government to issue orders for the extension of the contract appointment of Dr. P. Kanagasabapathi, Director, Tamil Nadu Institute of Urban Studies, Coimbatore for a further period of 3 months with effect from 22.01.2012 and accord permission to initiate action for the selection of a new candidate by following the procedure prescribed in the Regulations of the Tamil Nadu Urban Studies, Coimbatore.

6. The Government have examined the proposal of the Commissioner of Municipal Administration carefully and decided to accept it. Accordingly, the Government permit the extension of the contract appointment of Dr. P. Kanagasabapathi, Director, Tamil Nadu Institute of Urban Studies, Coimbatore for a further period of 3 months with effect from 22.01.2012 and accord permission to initiate action for the selection of a new candidate by following the procedure prescribed in the Regulations of the Tamil Nadu Urban Studies, Coimbatore.
