ORDER:

The name of Tamil Nadu Institute of Urban Studies (Regd. No.90/1982), Coimbatore, a Society registered under the Tamil Nadu Societies Registration Act, 1975 was struck off from the Register of Societies by the District Registrar, Coimbatore under section 44(4) of the above said Act for violation of provisions under section 26 of the above said Act for non convening of its General Body Meeting periodically and for the failure of submission of audit accounts and statutory documents regarding the Society continuously for 3 years under section 16 of the above said Act.

2. The Society has stated that the dissolution of the Society was published in the Tamil Nadu Government Gazette on 5.12.2007 under section 44(4) of the above said Act and requested to restore its name in the Register of Societies in the representation first read above. But the Society has preferred the appeal belatedly on 18.3.2013 i.e after a period of six years. The Society has further stated that the reason was because no notices under Sections 44 (2) and 44 (3) of the Tamil Nadu Societies Registration Act, 1975 were received by the said Society from the District Registrar, Coimbatore, as they (Tamil Nadu Government Gazette Notifications), were sent to the address where the Institute was functioning during the initial periods at No.15/55-c, Mettupalayam Road, Coimbatore-600 043.

3. The Society has requested the Government to grant exemption under rule 37(3) of Tamil Nadu Societies Registration Rules, 1978, for preferring the appeal belatedly after a period of one year by invoking section 54(1) of the Tamil Nadu Societies Registration Act, 1975 and to entertain the appeal against the name deletion order of the District Registrar.

4. The District Registrar, Coimbatore conducted an inspection and has reported that the society is carrying on its business and is in operation continuously. The above said Society is a Government promoted one and the Executive Committee Members are in the cadre of IAS officers. He has further reported that the above defunct Society has been properly maintaining the audit reports, balance sheet and income and expenditure statements from the years 2000-2001 to 2010-2011 and also for the year 2011-2012 and got approval from their General body Meeting on 28.12.2012 under section 26 of Tamil Nadu Societies Registration Act, 1975. The Inspector General of Registration has recommended to grant the exemption sought for by the said Society for restoration of their name in the Register of Society.

5. The Government carefully examined the request of the above said Society and the recommendation of the Inspector General of Registration, Chennai and based on the recommendations of the Inspector General of Registration, the Government have decided to accept the request of the above said Society.

6. In exercise of powers conferred under sub-section (1) of Section 54 of the Tamil Nadu Societies Registration Act, 1975 (Tamil Nadu Act 27 of 1975), the Governor of Tamil Nadu hereby exempts the Tamil Nadu Institute of Urban Studies (Regd. No.90/1982), Coimbatore District, a Society registered under the Tamil Nadu Societies Registration Act from the provisions of Rule 37(3) of the Tamil Nadu Societies Registration Rules, 1978 so as to enable the Society to prefer an appeal to the Inspector General of Registration under section 44(5) of the Tamil Nadu Societies Registration Act, 1975, to restore its name in the Register of Societies.
