ORDER:

The following Notification will be published in the Tamil Nadu Government Gazette:-

N O T I F I C A T I O N

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Municipal Commissioners' Service (Section 21-B in Volume II of the Tamil Nadu Services Manual, 1965)

2.The amendment hereby made shall be deemed to have come into force from 19.12.85.

A M E N D M E N T

In the said Special Rules, after rule 2-A, the following shall be inserted, namely;-

"2-B Qualifications: No person shall be eligible for appointment as Municipal Commissioners, Second Grade, and Personal Assistants to the Municipal Commissioners, Senior Grade I and Senior Grade II, by recruitment by transfer, unless he possesses the following qualifications, namely:-

1. Must have passed the departmental test for Municipal Commissioners in the Municipal Administration Department; and

2. Must have passed the District Office Manual test.

Provided that the Municipal Commissioners, Grade II as on the February 1983, are eligible for appointment as Municipal Commissioners, Second Grade, and Personal Assistants to the Municipal Commissioners, Senior Grade I and Senior Grade II, if they are otherwise qualified. Such persons shall pass the District Office Manual test, within a period of two years and the departmental test for Municipal Commissioners in the Municipal Administration Department within a period of three years from 19.12.85. If they fail to pass the said tests within the period aforesaid, they shall be reverted as Municipal Commissioners, Grade III at the end of the said period."
