## NOTIFICATION

In exercise of the powers conferred by sub-section (2) of section 8 of the Tamil Nadu Public Health Act, 1939 (Tamil Nadu Act III of 1939), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Municipal (Non-Centralised-Regular) Public Health Establishment Regulations, 1976.

2. The amendment hereby made shall come into force on the 17th June, 1973.

### AMENDMENTS

In the said Regulations, -

(1) for regulation 8, the following regulation shall be substituted, namely:--

"8 Appointing authority.- (1) Subject to the provisions of clause (a) of sub-section (1) of section 13 of the Tamil Nadu Public Health Act, 1939 (Tamil Nadu Act III of 1939) and the rules made thereunder, appointment to the posts shall be made by the Executive Authority of the Municipality or the Township Committee concerned.

(2) An appeal shall lie to the Director of Municipal Administration, Madras against all orders of the Executive Authority in respect of appointments";

(2) in regulation 19, for the expression "Additional Director of Health Services and Family Planning, Madras" the expression "Director of Municipal Administration" shall be substituted;

(3) in regulation 25, in sub-regulation (1), in the second proviso, for the expression "Additional Director of Health Services and Family Planning", occurring in two places, the expression "Director of Municipal Administration" shall be substituted;

(4) for regulation 26, the following regulation shall be substituted, namely:--

"26. Grant of Leave.- The Executive Authority shall be the authority competent to grant leave"; and

(5) in regulation 30, for the expression, "Additional

Director of Health Services and Family Planning", wherever it occurs, the expression "Director of Municipal Administration" shall be substituted
