ORDER:

In G.O.Ms.No. 1195, RD&LA., dated 29.6.'81 it has been ordered that the different components of property tax shall be rounded off to the nearest 10 paise and the fractions less than 10 paise be ignored. It has also been ordered therein that in respect of other taxes and fees, the fraction of 50 paise and above shall be rounded off to the next higher rupee and the fraction less than 50 paise be ignored. The Commissioner of Kovilpatti Municipality has reported that the above G.O. was received during July 1981 (that is after writing of the demand for property tax and other fees for 1981-82). Since the demand for property tax is common for I & II half year it would not be possible to write a separate demand of components of property tax for second half year after writing of the demand for first half year of 1981-82. He has also stated that it would be difficult to insert demand for second half year rounding off figures as per instructions in the above G.O. He has therefore requested the Government to give effect to the orders issued in G.O.Ms.No. 1195, RD&LA., dated 29.6.81 from the financial year 1982-83. The Director of Municipal Administration and the Examiner of Local Fund Accounts have also recommended the above request of the Municipal Commissioner, Kovilpatti.

2. The Government have decided to accept the above request of the Municipal Commissioner, Kovilpatti as recommended by the Director of Municipal Administration and Examiner of Local Fund Accounts. The Government accordingly direct that the orders issued in G.O.Ms.No. 1195, RD&LA., dated 29.6.'81 shall take effect from the financial year 1982-83.

3. This order issues with the concurrence of Final Department vide its U.O. Note No. 9662/RD&LA/83 dated 7.2.83
