The following amendments are issued to the Tamil
Nadu Financial Code, Volume-I (Corrected upto 30th June 1980):-

Amendment No.1/88

Page 178-Article 210-A(2):-

Add the following after the words "or mainly out of
Government grants" in the fourth line on page 178.

"The Register should be maintained by the grantee
institutions separately in respect of each
sanctioning authority".

Amendment No.2/88

Page 178-Article 210-A(2):-

Introduce the following as the 5th sub-para in
Article 210-A(c) on page 178.

"The sanctioning authorities should maintain Block
accounts also, in Tamil Nadu Financial code, Form 26
of Permanent and Semi-permanent assets acquired wholly
or mainly out of Government grants. This record should
be of a permanent nature and should be posted from the
annual returns furnished by the grantee institutions as
required in the para mentioned above".

Amendment No. 3/88

Page 178-Article 210-A(2):-

Introduce the following as the 6th Sub-para in Article 210-A(2) in page 178.

"Departments of Secretariat/Heads of Departments sanctioning the grant, shall take up the matter with the grantee institutions if the annual returns are not received in time, sothat they are in a position to maintain their own records complete as required under the rules".
