ORDER:

In the G.O. first read above, orders were issued permitting the implementation of Animal Birth Control Programme in 5 Corporations and 50 Municipalities. This has been further extended to all the Urban Local Bodies from the year 2008-2009, ordered in the Government order second read above.

2. The Commissioner of Municipal Administration in the letter third read above has sent proposals to Government to sanction a special grant of Rs.22.00 crore for the following works / activities to implement Animal Birth Control (ABC) Programme in Urban Local Bodies (ULBs).

3. The Government after careful examination proposed to sanction a special grant of Rs 5.40 crore (Five crore forty lakh only) towards non recurring expenditure activities as detailed below and order accordingly :-

In respect of the recurring expenditure such as the cost for allowance for the terminally ill and mortally wounded dogs in the Shelters and performing surgeries to dogs, the Commissioner of Municipal Administration is instructed to meet the expenditure from out of the funds of the Urban Local Bodies initially and get 50% of the expenditure reimbursed from the Animal Welfare Board of India.

4. Necessary funds has been provided in Budget Estimate 2013-2014.

5. The expenditure sanctioned in para 3 above shall be debited into the following head of account :-

2217-Urban Development – 80. General – 800. Other expenditure – Schemes in the Twelfth Five Year Plan – II. State Plan – JM. Implementation of Animal Birth Control and Anti Rabies Programme – 09. Grants in Aid – 03. Grants for specific Schemes. (DPC :2217-80-800-JM 0939)

6. The Commissioner of Municipal Administration is the Estimating, Reconciling and Controlling authority of the above new head of account.

7. The concerned Pay and Accounts Officers / Treasury Officers are instructed to open the new head in their books.

8. The Commissioner of Municipal Administration is authorized to draw and disburse the amount mentioned in para 3 above to the respective Urban Local Bodies.
