ORDER:

Sanction is accorded to the revival of a Chamber of Municipal Chairmen consisting of all the elected Chairmen of Municipal Councils with an Executive Committee consisting of seventeen members including the office bearers.

2. The Municipal Councils are permitted to pay an annual contribution to the Chamber of Municipal Chairmen from their funds towards the expenses of the Chamber for the year 1988-89 onwards at the following rates:-

3. The contributions sanctioned by the Municipal Councils for the purpose should be paid by cheque drawn in favour of the Chamber.

4. The Municipal Councils are also permitted to pay from their funds travelling allowance to their Chairmen for attending meetings of the Chamber of Municipal Chairmen which may be held not more than once in a year and meetings of the Executive Committee which may be held not oftener than once in three months.

5. The Executive Committee of the Chamber is requested to submit to Government an audited statement of accounts of its receipts and expenditure once a year in June for the year ending 31st March proceeding.
