



ABSTRACT

Stores – Purchase requirements – Stores by Government Departments Corporations/Boards/Local Bodies/Co-operative Institutions – Purchase preference to State public Sector Undertakings – Tamil nadu Khadi and Village Industries Board and Co-operative Institutions – Orders – Issued.

ORDER:

In para 4 of the Government Order first read above, it was ordered among other things that no purchase preference will be available to Co-operative Institutions. Also in Para 3 of the Government Order Second read above, it was ordered that the system of purchase preference shall continue to be operated as ordered in the G.O. first read above. In respect of State Public Sector Undertakings and Tamil Nadu Khadi and Village Industries Board, it was ordered that the priority will be continued for one more year for 1997-98, after which they will have to complete in open tenders with other suppliers but they may be given 50% of the orders if they match the lowest tender and this may be specifically indicated in the tender.

2. The Government have reviewed the orders on the purchase preference to State Public Sector Undertakings (SPSUS), Tamil Nadu Khadi and Village Industries Board and Co-operative Institutions. Inpartial modification of the orders issued in the G.O. first and second read above, the Government direct that the system of purchase preference for purchase of stores, servicing and repairing etc. shall continue to be operated as revised below:

- a. Jails/Borstal
- b. Schools under Prison Department for products made by them.
- c. Own Units of Khadi and Village Industries Board for items and quantities actually manufactured by them.
- d. Modern training-cum-production centre, Muttukkadu for the products made by it.

1. As State Public Sector undertakings will not be in a position to meet the entire requirements of Government Departments, other State Public Sector Undertakings, Statutory Boards etc. Government direct that the purchase preference will be given to State Public Sector Undertakings for products and quantities actually manufactured by them upto 50% of the value of the goods required by each department, Public sector Undertakings, Statutory Board etc. at the lowest rate obtained in the open tenders invited by them, even if the Public Sector undertakings have not participated in the tenders.

2. The Government also direct that permission for purchases from Co-operatives in respect of products manufactured by them without calling for tenders will be given only on a case to case basis on merits by the Government.

3. The Director of Stationery and Printing shall publish this order in the Government Gazette in the earliest issue.
