ORDER

In the Government order first read above, the Government have accorded consent under sub-section (2) of section 24 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) to the Mamallapuram Local Planning Authority for the publication of a notice of preparation of the master plan under section 26 of the said Act for Mamallapuram Local Planning Area.

2. The Commissioner of Town and Country Planning in his letter second read above has forwarded the draft master plan for the Mamallapuram Local Planning Area. He has requested the Government to accord approval to it under section 28 of the said Act.

3. The Government, after careful consideration accept the proposal of the Commissioner of Town and Country Planning in para 2 above. Accordingly, in exercise of the powers conferred by section 28 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu, after consultation with the Director of Town and Country Planning, hereby approves the said master plan for the Mamallapuram Local Planning Area. The copies of the said master plan for the Mamallapuram Area as approved by the Government are communicated to the Commissioner of Town and Country Planning.

4. The following Notification shall be published in the Tamil Nadu Government Gazette. The Commissioner of Town and Country Planning is requested to ensure that the Notification is republished in the manner as prescribed in rules 12 and 15 of the Master Plan (Preparation, Publication and Sanction) Rules.

NOTIFICATION.

In exercise of the powers conferred by sub-section (1) of section 30 of the Tamil Nadu Town and Country Planning Act, 1971(Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby publishes the approval of the Government under section 28 of the said Act for the master plan for the Mamallapuram Local Planning Area submitted by the Director of Town and Country Planning.

2. The approved master plan for the Mamallapuram Local Planning Area with all its enclosures shall be kept open for the inspection of the public in the office of the Mamallapuram Municipality during office hours.
