## **ORDER**

The Commissioner of Town and Country Planning in his letter read above has requested the Government to include certain villages to Udhagamandalam Local Planning Area, citing fast developments such as construction of cottages, restaurants / hostels, shops and to attract tourists in and around Udhagamandalam Local Planning Area under clause (b) of sub-section (1) of section 10 of Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. The Government, after careful consideration of the above proposal of the Commissioner of Town and Country Planning have decided to declare the intention of the Government to include additional areas in the Udhagamandalam Local Planning Area. The appended Notification will be published in the Tamil Nadu Government Gazette.

3. The Collector of Nilgiris District is directed to republish the Notification in the District Gazette.

4. The Director of Translation, Chennai-600 009, is directed to arrange to have the notification translated into Tamil and to forward the translation urgently to the Collector of Nilgiris District under intimation to the Government.

5. The Collector of Nilgiris District is directed to report to the Government, the date of republication of the notification in the District Gazette.

**NOTIFICATION.**

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to include additional areas in the Udhagamandalam Local Planning Area and to make the following amendment to the Rural Development and Local Administration Department Notification No.II(2)/RUL/2026/74 published at page 115 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 10<sup>th</sup> April 1974.
