### **ORDER**

In the Government Order first read above, orders were issued declaring the intention of the Government to notify the area comprising Pallipalayam Third Grade Municipality to be a Local Planning Area under clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. In the Government Order third read above, orders were issued declaring the area comprising Pallipalayam Third Grade Municipality as Pallipalayam Local Planning Area under sub-section (4) of section 10 of the said Act.

3. In the Government Order second read above the Pallipalayam Municipality Grade-III was upgraded to Grade-II Municipality.

4. In the letter fourth read above, the Director of Town and Country Planning has requested to constitute the Local Planning Authority for Pallipalayam Local Planning Area under section 11 (1) of the said Act.

5. The Government, after careful consideration, accept the proposal of the Director of Town and Country Planning in para 4 above. Accordingly, in exercise of the powers conferred by the proviso to sub-section (1) of section 11 of the said Act, the Governor of Tamil Nadu, in consultation with the Director of Town and Country Planning, hereby declares the Pallipalayam Municipal Council to be the local planning authority for Pallipalayam Local Planning Area.
