Urban Development - National Institute of Urban Affairs - Creation of Enrolment of Local Bodies and Development Authorities as Members and sanction of foundation grant - orders issued -

ORDER:

In the letter first read above, the Government of India have stated that it is proposed to set up a National Institute of Urban Affairs at New Delhi. The Institute is expected to be a premier Institution in the field of the Urban Sciences. It is designed to develop into an organisation for applied research in urbanology to help evolve a long term perspective of urban growth, to assist the Central, State and Union Territories Governments in policy formulation for urban development and to provide guidance, counselling and consultancy services to local bodies and development authorities. The Institute would also undertake regional studies in order to encourage the development authorities. The Institute would also undertake regional studies in order to encourage the development of a properly balanced rural urban continuum.

2. The Government of India have requested this Government to help the proposed National Institute in the following two ways:-

- a) Persuade the local bodies and development authorities in this State to become members of the Institute.
- b) To give a foundation grant of Rs.1 lakh from this State to the Institute.

3. The Government have examined the above two requests carefully and they pass the following orders:-

Item (A) Above:-

The schedule of fee for membership is as follows:-

Development Authorities and Corporations: Rs.5,000 Admission Fee  
Rs.2,500 subscription  
per annum.

Municipalities, Municipal Committees and Rs.1,000 subscription  
per annum.

The Government have decided to permit the following officers and local bodies to become members of the Institute mentioned above.

- (1) Director of Town and Country Planning, Madras.
- (2) Member-Secretary, Madras Metropolitan Development Authority
- (3) Commissioners of Corporations of Madurai and Coimbatore.
- (4) Commissioners of Tiruchirapalli, Salem, Vellore and Erode Municipalities.

F.T.O.

They are permitted to pay from the Departmental organisation funds the necessary admission fee of Rs.5,000/- and subscription and the subscription of Rs.1,000/- P.A. alonge in the case of others as prescribed in the schedule of fee.

Item (B) Above:-

The Government regret their inability to concede the request for sanction of foundation grant to the Institute.

4. The fees payable by the Director of Town and Country Planning should be debited to "284. Urban Development A.General-AC Town and Regional Planning-A.A. Director of Town Planning 04. Office expense-D.P:Code No.284.A.ACA1.0404" while the fees payable in the case of others will have to be met from the funds of organisation/local bodies.
