### ORDER:

In the Government order first read above, the Government have sanctioned a sum of Rs.8.50crore as special grant for implementation of various activities to intensify Animal Birth Control and Anti Rabies Programme in Town Panchayats during the year 2012-2013 with the conditions that the expenditure will be initially met by sanction of an advance from the Contingency Fund. The Director Town Panchayats was also directed to send necessary proposal to Government in Finance (BG1) Department in the prescribed format for sanction of an advance required for the current year from Contingency Fund.

2. In the letter second read above the Director of Town Panchayats has informed that he has sent the necessary proposal to Government in Finance (B.G) Department for releasing the funds from contingency fund, but no funds were released from the contingency fund by the Government. Since there is provision in the Budget Estimate 2013-2014, the Director of Town Panchayats has requested the Government to release a sum of Rs. 8.50crore for the implementation of various activites to intensify Animal Birth Control and Anti Rabies Programmes in Town Panchayats for the year 2013-14.

3. The Government after careful examination, accept the proposal of Director of Town Panchayats and accord sanction to release a sum of Rs.8.50crore (Rupees Eight Crore and Fifty Lakhs Only) for implementation of Animal Birth Control and Anti Rabies Programme in Town Panchayats.

4. The amount sanctioned in para 3 above shall be debited to the following head of Account:-

"2515-00 – other Rural Development Programmes – 800. Other expenditure – Schemes in Twelfth Five Year Plan-II– State Plan KX. Implementation of Animal Birth Control and Anti Rabies Programme in Town Panchayats – 09. Grants in aid – 03. Grants for Specific Schemes (DPC:2515-00-800-KX-0931)".

5. The Director of Town Panchayats is authorized to draw and disburse the amount sanctioned in para 4 above to the respective Town Panchayats.
