ORDER:

2. In the Government Order second read above, the Government have sanctioned and released a sum of Rs.200 crore, provided in the Budget Estimates 2013-2014 for implementation of projects sanctioned under Integrated Urban Development Mission (IUDM) scheme.

3. In the letter third read above, the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has now requested the Government to release an

amount of Rs.250.00 crore under Integrated Urban Development Mission (IUDM) scheme to Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited.

4. The Government after careful examination of the proposal of Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited above, accord sanction and release an amount of Rs.250.00 crore (Rupees Two hundred and fifty crore only) for implementation of projects sanctioned under Integrated Urban Development Mission (IUDM).

5. The amount sanctioned in para 4 above shall be debited to the following head of account:-

"4217 - Capital outlay on Urban Development

60 - Other Urban Development Schemes

800 - Other Expenditure - Schemes in the Twelfth Five Year Plan
II - State Plan

JJ - Integrated Urban Development Mission

The Commissioner of Municipal Administration is authorized to draw the amount sanctioned in para 4 above and credit to the P.D. account, viz. **"Integrated Urban Development Mission Fund"** maintained by the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited (TUFIDCO) and releasing the same to the IUDM projects approved by the **Project Sanctioning and Monitoring Committee.**
