Sub: Public Services – Typists and Steno-typists Grade-III appointed temporarily in Tamil Nadu Ministerial Service / Tamil Nadu Judicial Ministerial Service / Tamil Nadu Secretariat Service – Conducting of Special Competitive Examination at Group-IV level – Candidates ousted for want of vacancies – Accommodation of such candidates in other offices in the same District – Instructions – Issued.




As per the orders issued in the Government Orders 1st, 2nd, 3rd & 5th read above, suitable persons were appointed temporarily as Typists and Steno-typists Grade-III in the Tamil Nadu Ministerial Service / Tamil Nadu Secretariat Service as per the rules of procedure framed. It has now, been brought to the notice of the Government that in many offices the above said temporary Typists and Steno-typists are getting ousted from service for want of vacancies while appointing the Typists and Steno-typists Grade-III who are selected and allotted by the Tamil Nadu Public Service Commission through direct recruitment. As there may be vacancies in other offices in the district, Government have decided that in the interest of administration they may be appointed by redeployment in other offices of the same district where there are vacancies. The redeployment may be ordered by the Collector.

2. All the Collectors are, therefore, directed to pursue immediate action for the redeployment of the temporary Typists and Steno-typists Grade-III who have been appointed as per the orders referred to above and ousted from service for want of vacancies, consequent on joining of regular candidates selected by the Tamil Nadu Public Service Commission in other offices of the same District where there are vacancies. The temporary Typists and Steno-typists Grade-III may be ousted from service, if there is no vacancy in the concerned District.
