ORDER:

In the Government Order first read above, the Government has sanctioned and released an amount of Rs.765.12 lakh as 2nd installment of Government of India share to Aruppukottai Municipality for the year 2012-13 under Jawaharlal Nehru National Urban Renewal Mission (JNNURM) - Integrated Housing and Slum Development Programme (IHSDP) scheme.

In the letter second read above, the Commissioner of Municipal Administration has informed that the above amount has been disbursed to the Urban Local Body by the State Level Nodal Agency (SLNA) and the Urban Local Body has made expenditure upto 70%. He has therefore requested the Government to issue orders for sanction and release of an balance amount of Rs.147.33 lakh as 2nd installment of Government of Tamil Nadu matching share to the Aruppukottai Municipality for the year 2013-14 under Integrated Housing and Slum Development Programme (IHSDP) scheme.

The Government after careful examination accept the proposal of the Commissioner of Municipal Administration at para 2 above and accord sanction and release the State share amount of Rs.147,33,000/- (Rupees One crore forty seven lakh thirty three thousand only) towards 2nd installment for Aruppukottai Municipality under Integrated Housing and Slum Development Programme (IHSDP) scheme for the year 2013-14.

4. The amount sanctioned in para 3 above shall be debited under the following head of account:-
