



ABSTRACT

WATER SUPPLY – Erode and Tiruppur Districts – Combined Water Supply improvement Scheme to 1262 rural habitations in Veliakoil, Mulanur, Dharapuram, Kundadam, Kangayam unions in Tiruppur district and Chennimalai union in Erode district with the bulk provision made in Combined Water Supply Improvement Scheme to Vellakoil and Kangeyam Municipalities and 528 rural habitations in Erode and Tiruppur Districts with River Cauvery near Kodumudi as source at a cost of Rs.91.16 Crore to install and Rs.352.80 Lakh to maintain annually – Approved by the Empowered Committee –Administrative Sanction - Orders - issued.

ORDER:-

The Managing Director, Tamil Nadu Water Supply and Drainage Board in his letter read above, has stated that following the announcement made by the Hon'ble Chief Minister on the floor of the House, a Detailed Project Report for Combined Water Supply Improvement Scheme to 1262 rural habitations in Vellakoil, Mulanur, Dharapuram, Kundadam, Kangayam unions in Tiruppur district and Chennimalai union in Erode district with the bulk provision made in Combined Water Supply improvement Scheme to Vellakoil and Kangeyam Municipalities and 528 rural habitations in Erode and Tiruppur Districts with River Cauvery as source near Kodumudi has been prepared.

2. In this connection, the Managing Director, Tamil Nadu Water Supply and Drainage Board has stated that the existing Muthur-Kangeyam Combined Water Supply Scheme formulated during 1996 as separate network system considering the valid local source schemes and executed in various stages covers the entire area of the proposed Project except the 796 Rural habitations where water supply is effected only through local sources. The demand of the proposed Project has been arrived in such a way that the designed supply (both at Intermediate and Ultimate Stages) from the existing Muthur-Kangeyam Combined Water Supply Scheme to the beneficiaries of the proposed Project are fully utilized as per the sanctioned estimate of the Scheme. As such all the existing components of the Muthur-Kangeyam Combined Water Supply Scheme will be utilized fully by all the original beneficiaries. Considering the vast extent it was proposed to formulate and execute the scheme in two phases. The phase-I of the project includes 528 rural habitations in Vellakoil, Mulanur and Kundadam Unions of Thiruppur District and Phase-II covers 1262 rural habitations in Kangeyam, Vellakoil, Mulanur, Dharapuram, Chennimali Unions of Thiruppur and Erode District. The Administrative Sanction for Phase-I has already been accorded in the Government Order read second above. The present proposal is for implementing Phase -II.

3. The Managing Director, Tamil Nadu Water Supply and Drainage Board has informed that the source for the project is the surface water of river Cauvery near Kodumudi on the upstream of existing Head works of Muthur-Kangeyam Combined Water Supply Scheme. The above proposal was cleared by the Regional Scientific Source finding Committee (RSSFC) in its Meeting held on 24.8.2007. Based on the Water Utilisation Committee's (WUC) recommendations, the Government has permitted to draw 15.18 MLD of surface water from River Cauvery near Emagundnallur in Kodumudi in Erode District vide Government Order first read above. The proposal was also cleared by the State Level Technical Committee (SLTC) in its Meeting held on 18.07.2013.

4. The Managing Director, Tamil Nadu Water Supply and Drainage Board has informed that the cost of the above scheme is Rs.91.16 Crores to install and Rs.352.80 lakhs to maintain annually under NRDWP /MNP (SMS) as detailed below.

The Tamil Nadu Water Supply and Drainage Board in its resolution No.2.9, dated 24.7.13, has resolved to recommend to the Government through the Empowered Committee for according Administrative Sanction for this proposal. The Board further RESOLVED that the implementation of this proposal may be taken up on completion or nearing completion of phase I namely Combined Water Supply Scheme to Vellakoil and Kangeyam Municipalities and 528 Rural habitations in Erode and Tiruppur District, since quantity provisions for this proposal is available in phase I only.

6. Based on the recommendation of the Board the Empowered Committee has accepted the above proposal and recommended to the Government for according Administrative Sanction for the proposal.

7. The Government after careful examination accord Administrative Sanction for the proposal for providing Combined Water Supply Improvement Scheme to 1262 rural habitations in Vellakoil, Mulanur, Dharapuram, Kundadam, Kangayam unions in Tiruppur District and Chennimalai Union in Erode District with bulk provision made in Combined Water Supply Improvement Scheme to Vellakoil and Kangeyam Municipalities and 528 rural habitations in Erode and Tiruppur Districts with River Cauvery as source near Kodumudi at a cost of **Rs.91,16,00,000/- (Rupees Ninety One Crore and Sixteen Lakh Only)** to install and **Rs.352,80,000/- (Rupees Three Crore Fifty Two lakh and Eighty Thousand Only)** to maintain annually under NRDWP / MNP (SMS).

8. The Managing Director, Tamil Nadu Water Supply and Drainage Board is requested to ensure that the implementation of this proposal is taken up on completion or nearing completion of phase I namely Combined Water Supply Scheme to Vellakoil and Kangeyam Municipalities and 528 Rural habitations in Erode and Tiruppur District, since quantity provisions for this proposal is available in phase I only.
